It is to clarify in this appeal that:</p> <ul style="list-style-type: none"> - All the events that take place in our college are distinct and not related to each other in a particular year. - The closeness of dates is solely due to students' participation in independent events at other colleges or universities. <p>We understand that the SOPs mention considering all events or activities in which students have participated, including those outside of our college. Nevertheless, it appears that this aspect is not being taken into account in the current assessment. We kindly request that you reconsider our case, giving due consideration to the students' participation in other colleges' events, as per the SOPs. We believe this clarification and reconsideration will ensure a fair assessment of our situation.</p>
